General Campground Rules

&

Non-Seasonal Campground Sites Fees Policy

Effective Date: April 2024

ELIGIBILITY

The Campground facilities will be available for use only by Members in good standing and their guests. (NOTE: Only Members are eligible for yearly, seasonal, or monthly rates).

In addition, camping privileges may be available to a non-Member with special approval of Management on a limited basis.

The Campground is for non-residential recreational use only. Permanent camping is not allowed.

The Campground does not allow for campsites to be sub-leased for short-term rental purposes of any kind.

RESERVATIONS

To ensure availability of open campsites, reservations must be made in advance. **Your reservation is not confirmed until you have spoken to the Campground Chair.**

CAMPSITE GUIDELINES

Each campsite will have no more than one (1) camper plus one (1) tent, OR two (2) sleeping tents. Screen rooms are not considered a tent.

Total occupancy per site is eight (8) people.

Two (2) vehicles per campsite are allowed and must be parked completely clear of the road surface. Additional parking, if needed, is available in a designated overflow area. Please see the Campground Chair for assistance with extra vehicles.

MEMBER RESPONSIBILITY

Members are directly responsible for the actions of themselves, their family, their pets, and their guests. Any unpaid campsite fees from guests as well as any damage to, or loss of Association property are also the sole responsibility of the Member.

Warbler's Hideaway Association is not responsible for lost or damaged property.

For the safety of all campers and pets, all pets must be kept on a leash or a tie-out. Pets are not allowed in the bathhouses, pavilions, the Clubhouse, pool, or playgrounds. Members and guests must clean up after their pets and properly dispose of the droppings (not in the bathhouses). Members and guests may run dogs in the field to the north of the Campground or the field by the Clubhouse.

The speed limit for all motorized vehicles is 5 MPH. Please help keep everyone safe and use extra caution when driving in the Campground.

Campfires must be contained in the fire rings provided on each site. Burning food or garbage is not permitted. All fires must be put out when unattended.

Dishwashing is not permitted at the drinking fountains or in the bathhouses.

Garbage must be put in a plastic bag and placed in the dumpster located behind the maintenance barn.

As a family-friendly Campground, excessive offensive behavior is not allowed.

Under no circumstances are fireworks allowed, nor are firearms or archery permitted to be discharged in the Campground.

Quiet Hours are from 11:00pm to 8:00am. Please be courteous of your neighbors and keep noise to a minimum. The pavilions can always be used if having multiple people at your campsite to help keep noise down.

REGISTRATION & PAYMENT INSTRUCTIONS

Check-in time is 3:00pm. Check-out time is 1:00pm. The daily camping fee is \$25.00. The weekly camping fee is \$150.00. Rates are subject to change at the discretion of the Association. Please refer to the Association website for the most up to date rates. Cash (preferred) and personal checks are the accepted forms of payment, and payment is due upon arrival.

To register for a campsite, go to the Check-In Station (located across from the Campground bathhouse), and fill out a Campers Permit Form. Put the completed form with payment in an envelope and drop in the green collection tube.

*****Please be advised that these rules are subject to change at the discretion of Management.**

Management also has the authority to initiate any new rules or policies as necessary for the welfare and safety of the campers and the Association. ***
