We did a charge off of \$6,500 uncollectible debt that we had been carrying on the books since before 2016 from previous members that no longer owned the property. We have recovered over \$2,000 in past dues thanks to the many efforts of our secretary, Robin Thoms.

Currently, we have \$14k in past dues that have liens placed on the member's property in additional efforts to collect funds owed.

IMPORTANT INFORMATION FOR THE 2024 MAIL IN BALLOTS FOR BOARD OF DIRECTORS

There are (3) three positions available for Warbler's Hideaway Board of Directors for a term of (3) three years. All mail-in ballots must be in the hand of the Warbler's Secretary prior to the October 5, 2024 annual board meeting or you may bring your ballot to the meeting if you are attending. You may also place your ballot in the black box at the front of the Association (not the white suggestion box), but please place it in a sealed envelope. You may vote for up to (3) three candidates of your choice by placing an X next to their name. Each candidate selected will recieve the same number of votes matching the total number of lots you own.

These ballots are handled with the utmost discretion. Once received, the envelopes are placed in a locked safe to ensure no tampering is possible. Envelopes are not opened until the day of the meeting and are opened in the presence of the members attending the meeting. Only ballots with the Warbler's Hideaway seal are official. I am excited to be running for a position on the Warblers Hideaway Homeowners Association Board of Directors again. I last served on the Board from 2019-2023.


My wife Jackie and I have been homeowners in the association since 2015. I am an engineer for an
